Natasha, 35, Singaporean started her professional journey as a **Human Rights, Gender and Legal Advisor** to the United Nations, INGOs and NGOs for 15 years - where she oversaw large impact grants, examined compliance by States and institutions on international human rights standards and executed Strategies, Policies and Programs. She led consensus-building missions with stakeholders to co-develop policies, strategies and put in place governance processes to build rights-based institutional cultures, and, prevent and redress negative human rights impacts.

## <u>Committee on the Elimination of Discrimination against Women (CEDAW) on "Equal and inclusive representation of women in decision-making systems", 2023</u>

Our Submission addressed recommendations to States parties to the Convention on the measures they should adopt to ensure full compliance with their obligations to respect, protect and fulfill women's human right to equal and inclusive representation in decision-making systems.
